ELIGIBILITY, RULES AND REGULATIONS FOR ADMISSION TO M.TECH AND M.TECH (SELF FINANCE) PROGRAMME THROUGH INSTITUTE SPOT ROUND

1. INTRODUCTION

The full-time M.Tech and M.Tech (Self Finance) Programmes are offered in the following Departments and Centre:

1. Civil Engineering.
2. Electrical Engineering.
3. Mechanical Engineering.
4. Electronics and Communication Engineering.
5. Metallurgical and Materials Engineering.
6. Chemical Engineering.
7. Computer Science and Engineering.
8. Biotechnology.
9. Centre for Materials and Manufacturing:

The vacancy status of seats for Institute Spot Round (ISR) will be displayed on **August 12, 2025**, i.e., after the physical reporting of candidates who already got provisional seat allotment to M.Tech (through CCMT) and M.Tech (Self Finance) programmes at NIT Warangal (NITW). The vacancy includes: (i) seats not filled through the CCMT-2025 counselling process and Institute admissions for M.Tech (Self Finance) programme, (ii) vacancies arising due to those candidates who failed to physically report to NITW after getting provisional seat allotment through CCMT-2025 for M.Tech (Regular) programme and Institute admissions for M.Tech (Self Finance) programme. The vacant seats in M.Tech (Regular) programme will be initially offered to candidates with valid GATE score. The left over seats (if any), will be offered to candidates without valid GATE score. However, such candidates will not be eligible to receive stipend. The vacant seats in M.Tech (Self Finance) programme will be offered to candidates based on the performance in both written test and interview. Candidates with valid GATE score can also apply for M.Tech (Self Finance) programme (if they wish). However, they should submit separate registration form for M.Tech (Regular) and M.Tech (Self Finance) by paying both the relevant registration fee. **Written test and interview are mandatory for admission to M.Tech (Self Finance) programme for all candidates (both with and without valid GATE score).**

Candidates admitted to M.Tech programme at NITW through CCMT-2025 and M.Tech (Self Finance) programme through Institute admissions while retaining their seats for which they have already secured admission can also participate in the Institute spot round by paying the relevant registration fee and by submitting the registration form online. **In case, a new**

seat is allotted in Institute spot round, then their retained seats will automatically get cancelled and the candidates will not have any claim on the previously secured seats either through CCMT-2025 or Institute Admissions-2025.

All the M.Tech specializations at NITW will be displayed to the candidates, irrespective of vacancy status. Candidates are advised to carefully fill their choices in the order of priority depending on their eligibility for a specific M.Tech programme in one or more Departments. It is the responsibility of the candidates to check their eligibility for specific M.Tech programme. The choices need to be filled at the time of registration in the “Application Portal”. No new choices can be added after registering in the “Application Portal”. However, the candidates can change the order of priority while filling the details in “Application Portal”. Once the registration form is submitted, the entered choices and order of priority cannot be edited. **Candidates must fill and save at least one M.Tech specialization to be considered for seat allotment in the Institute spot round.** *Candidates who fail to fill and save at least one M.Tech specialization will not be considered for seat allotment and admission in Institute spot round.* The vacancy seat matrix to be displayed to the candidates on the NITW website (<https://www.nitw.ac.in/notifications>) is tentative. **Some additional vacant seats may be available at a later stage of Institute spot round. Therefore, candidates are advised to fill-in their choices of seats irrespective of the vacancy status depending on their eligibility for specific M.Tech specializations in one or more Departments.** Seat allotment will be carried out according to GATE score for M.Tech programme and performance in written test and interview for M.Tech (Self Finance) programme.

Note:

- i) Valid GATE score is **mandatory** for admission to M.Tech programme with stipend. Valid GATE score is **not mandatory** for admission to M.Tech (Self Finance) programme without stipend.
- ii) Rules of reservation are applicable to M.Tech admissions for candidates with valid GATE score whereas the rules of reservation are not applicable to M.Tech (Self Finance) programme.
- iii) Candidates with valid GATE score are exempted from written test and interview. All candidates applying for M.Tech (Self Finance) Programme irrespective of the category must appear for Written Test/ Interview. The written test for M.Tech (Self Finance) would be based on GATE syllabus.

3. ELIGIBILITY

Candidates are strongly advised to ensure that they fulfill the eligibility criteria as mentioned below before registration for participation in Institute spot round. For candidates with valid GATE score, admission to M.Tech. programme will be as per the CCMT-2025 norms and the special eligibility conditions of NITW as shown below. Please see mapping of [Institute, Department, PG Specialization] with [GATE Paper & Qualifying Degree] at the following link by selecting the Institutes as “National Institute of Technology, Warangal”, relevant Department, relevant M.Tech specialization (PG

Program Name), Group Name as “ALL”:

If the candidate's Qualifying Degree is not mapped with a specific M.Tech. Specialization, such candidate even with valid GATE score are not eligible for admission to the specific M.Tech specialization.

For candidates without valid GATE score, admission to M.Tech (Self Finance) programme will be as per the special eligibility conditions of NIT Warangal as shown below and Department specific eligibility conditions shown in Point 7 (page 7 to 9).

Minimum 60% aggregate marks or 6.5 CGPA in the qualifying degree for GEN/ GEN-EWS/ OBC-NCL category candidates and minimum 55% aggregate marks or 6.0 CGPA for SC/ ST/ PwD category candidates.

4. DETAILS OF THE INSTITUTE FEE

5. HOSTEL AND MESS FEES TO BE UPLOADED IN SMILE PORTAL

All admitted candidates are required to stay in the Institute hostels. Each PG student has to pay **Rs.43,000/-** towards hostel accommodation in the odd semester of the academic year 2025-26.

6. INSTRUCTIONS TO APPLY

Registration is mandatory to participate in the Institute spot round. Registration form is to be submitted online which is available at: <https://admissions.nitw.ac.in/>

All the necessary documents are to be uploaded online.

The link to pay registration fee (Rs. 2,000/- for all the applicants) is given in your registered login page.

Other payments like mobile payments (IMPS), NEFT, RTGS and direct transfer will not be accepted. If paid by any chance, it will not be refunded. Do not use mobile applications to make the payment.

Note: *The registration fee once paid will not be refunded under any circumstances.*

All the necessary documents are to be uploaded online. Candidates are advised to save the

entered data on each page at regular intervals and press the “Submit Application” after ensuring the entire data has been entered and relevant documents have been uploaded. Please ensure that you satisfy all the eligibility requirements before paying the registration fee. The candidates who are employed and wish to apply for M.Tech or M.Tech (Self Finance) programme must enclose a NO OBJECTION certificate from the employer (see the Annexure-I given at the end).

- Valid GATE score card [mandatory for M.Tech (Regular) and not mandatory for M.Tech (Self Finance)].
- SSC/ Class X certificate in support of Date of Birth.
- Intermediate/ (10+2)/ Class XII certificate.
- Category certificate [if applicable] (in case of GEN-EWS (Annexure-I)/ OBC-NCL (Annexure-II) along with undertaking/ SC/ ST candidates). EWS and OBC-NCL certificates should have been issued on or after April 1, 2025. Candidates from Maharashtra state should submit the caste validity certificate also.
- PwD certificate (if applicable).
- No Objection Certificate from the employer (Annexure-III, if employed).
- Relieving certificate or study leave approval from the employer (at the time of admission, if employed).
- Photograph on registration form.
- B.Tech/ M.Sc. Provisional/ Degree Certificate/ Course Completion Certificate (issued by the Head of the Institute, in case of present final year/semester results are awaited).
- B.Tech/M.Sc. Marks Sheets / Consolidated Marks Memo.
- Students admitting through M.Sc. with valid GATE score should submit both UG and PG marks sheets and degree certificates.
- Grade/ Rank Card of GATE, if any.
- Study and Conduct Certificate.
- Transfer/ College Leaving Certificate (**original to be submitted at the time of physical reporting**).
- Migration Certificate (**original to be submitted at the time of physical reporting**).

Note: Use self-declarations (available at the end of this document) if any documents are not available. If selected, all the pending documents (if any) should be submitted on or before September 30, 2025 failing which their allotted seat will be cancelled automatically.

IMPORTANT:

- NIT Warangal is a fully residential Institute. All the M.Tech. (with valid GATE score) and M.Tech. (Self-Finance) students admitted to NIT Warangal are required to stay on campus.
- Candidates should note that the Institute will neither make any allowances for delays and irregularities in submitting application.
- If the candidate cancels the seat, the application form fee will not be refunded, but the other fee will be refunded as per the institute refund rules.
- In case, the result of qualifying degree is awaited, provisional admission is permitted to a candidate subject to meeting above minimum qualifying degree requirements latest by September 30, 2025. In these cases, all exams should have been completed by August 15, 2025. A certificate from the Head of the current institute to that effect should be submitted during document verification.
- No employee shall be admitted as a regular full-time student of any full time Post Graduate course, unless he/she is relieved of his/her duties by his/her employer and unless a proper relief certificate for pursuing M.Tech. Degree is produced to that effect.
- The short-listed candidates' list will be notified in the institute website and no separate call letters shall be sent to the candidates.
- If any candidate has admitted due to any discrepancies in the processing of the application, the Institute reserves the right to cancel the seat before admission is made final, without payment of any compensation for the inconvenience caused.
- If it is found that any of the applicants admitted to the Institute has either furnished wrong information or tampered with the records, his/her admission is liable to be cancelled at any stage.
- The Institute reserves the right to cancel the admission of any candidate at any stage (even after admission) if any discrepancy is found (or) on the basis of adverse remarks in the Conduct Certificate.
- The PwD candidates will be required to undergo the medical examination by the medical board of the NIT Warangal at the time of physical reporting as per schedule mentioned on the NIT Warangal website. Based on medical examination at the NIT Warangal, if the medical board finds the candidate ineligible for PwD category at that time, her/his seat may be cancelled.
- Wherever ambiguities arise in the interpretation of Admission Rules, the decision of the Director of this Institute on the matter shall be final.
- The Director is authorized to take appropriate decision with regard to any other details of admission not covered by the rules listed above.
- Any legal dispute arising out of this admissions notification is subject to the Courts having jurisdiction over Warangal, Telangana.
- The decision of the Institute in all matters will be final and binding on all the applicants who respond to this admissions notification. No interim correspondence or unsolicited query will be entertained from the applicants in connection with the process of scrutiny/selection including reasons for not being shortlisted for written test/interview.
