# ABOUT THE PROGRAMME

---

In the contemporary world of rapidly changing global business, which is technology-driven and consumer-oriented, the acumen needed for managers is being revolutionized. Recognizing this, the institute has designed a comprehensive MBA programme. Thus came to light the "School of Management", now known as Department of Management Studies (DMS), in the precincts of NIT Warangal. The department has an annual intake of 77 students selected on the basis of CAT / MAT/ GMAT scores every year. The focus of DMS is on its premier, 2-year, full-time MBA programme. The course is offered in four semesters. In first year, along with fundamental courses, labs, mandatory non-credit courses are offered to create a holistic learning. After 2nd semester, the students are required to undertake summer training in an organization. In the last semester, the students are required to undertake projects in their chosen area of specialization.

# LIFE AT DMS NIT Warangal

Life at DMS is a scintillating journey through education, with a harmonious blend of academic and non-academic learning that goes beyond the conventional classroom method. Teaching methodology in the department is not governed by any rulebook, but by the emancipation of thought process.

The state-of-the-art AC classrooms are equipped with Wi-Fi enabled web-architecture and cyber infrastructure, access to latest software and statistical packages like IBM SPSS & AMOS industry databases like Capitaline Plus and periodically updated electronic journal databases comprising articles of national and international journals. Classroom learning is consolidated by combining "lectures" with real time "case studies" blended with student faculty interactions, student seminars, in-basket exercises, field experiences, presentations and industry interactions with a continuous evaluation pattern.

# ADMISSION INTO MBA

## ELIGIBILITY

Any Bachelor's degree with at least 60% aggregate marks or 6.5 CGPA on 10-point scale with a valid CAT/MAT/GMAT score are eligible to apply for the programme.

SC/ST/PwD Candidates with 55% aggregate marks or 6.0 CGPA on 10-point scale and a valid CAT/MAT/GMAT score are eligible to apply for the programme.

## APPLICATION FEE

1. Application fee is Rs. 2000/- for GEN/OBC-NCL/GEN-EWS candidates and Rs. 1000/- for SC/ST/PwD candidates.
2. Applications are to be submitted online along with legibly scanned copies of necessary certificates and payment receipt. Payment links and necessary documents are available on the portal.



# ADMISSION METHODOLOGY

1. Admissions are made on ALL INDIA BASIS.
2. Selection will be based on a valid CAT/MAT/GMAT score followed by group discussion and personal interview.

## IMPORTANT INFORMATION

- NIT Warangal is a fully residential Institute. All the MBA students admitted to NIT Warangal are required to stay on campus.
- Candidates should note that the Institute will neither make any allowances for delays and irregularities in submitting application.
- Applications submitted online in any Proforma other than the one provided in the Institute web site ([www.nitw.ac.in](http://www.nitw.ac.in)) or those received after the due date or those, which are incomplete in any respect, will not be considered.
- If two or more candidates obtain the same marks, the aggregate percentage of marks they obtained at the qualifying degree examination, will be the criterion for selection of the candidate. In case of further tie, elder person by age will be given preference.
- Reservations for GEN-EWS, OBC-NCL, SC and ST including PwD will be as per the norms of Government of India.
- Applicant should be a citizen of India.
- Admission of foreign nationals, if any, shall be governed by the rules stipulated by the Government of India from time to time.
- No employee shall be admitted as a regular full-time student of any full time Post Graduate course, unless he/she is relieved of his/her duties by his/her employer and unless a proper relief certificate for pursuing MBA Degree is produced to that effect.
- The short-listed candidates' list will be notified in the institute website and no separate call letters shall be sent to the candidates.
- In case, the result of qualifying degree is awaited, provisional admission is permitted to a candidate subject to meeting above minimum qualifying degree requirements latest by September 30, 2025. In these cases, all exams should have been completed by August 15, 2025. A certificate from the Head of the current institute to that effect should be submitted during document verification.

- If any candidate has admitted due to any discrepancies in the processing of the application, the Institute reserves the right to cancel the seat before admission is made final, without payment of any compensation for the inconvenience caused.
- If it is found that any of the applicants admitted to the Institute has either furnished wrong information or tampered with the records, his/her admission is liable to be cancelled at any stage.
- The Institute reserves the right to cancel the admission of any candidate at any stage (even after admission) if any discrepancy is found (or) on the basis of adverse remarks in the Conduct Certificate.
- If the candidate cancels the seat, the application form fee will not be refunded, but the other fee will be refunded as per the institute refund rules.
- The Institute Medical Officer will examine candidates who are provisionally selected for admission and those who fail to satisfy the physical fitness standard prescribed by the Institute will not be admitted.
- Candidate's name will be provisionally included in the Rolls only when the selected candidate reports at the Institute (Online/offline depending on the situation) for admission, submits all the required certificates, in original, found to be medically fit and pay all the fees and deposits prescribed.
- Wherever ambiguities arise in the interpretation of Admission Rules, the decision of the Director of this Institute on the matter shall be final.
- The Director is authorized to take appropriate decision with regard to any other details of admission not covered by the rules listed above.
- Any legal dispute arising out of this admissions notification is subject to the Courts having jurisdiction over Warangal, Telangana.

No interim correspondence or unsolicited query will be entertained from the applicants in connection with the process of scrutiny/selection including reasons for not being shortlisted for GD and Interview.
